CSG Shareholder Agreement

I wish to become a member of the Community Supported Garden at Genesis Farm (CSG) by sharing the economic responsibilities as well as the bounty of vegetable and fruits from this farm. I understand that the gardeners are committed, to the best of their abilities, to grow produce using biodynamic, organic methods.

I understand that this is a community supported effort, and that there are risks of crop difficulties, e.g. drought or too much rain, insect and/or deer damage, etc. I agree that in the event of expenses exceeding the amount budgeted in the garden, I will pay an additional amount not exceeding 7.5% of my original commitment. To date, this has never happened.

I also understand that if I cannot continue my share, I will be responsible for the balance of the share.

I agree that if it is necessary for the CSG to utilize an attorney to collect the balance due, I will be responsible for costs of collection and reasonable attorney fees.

Important Notes

From May to November, pick-ups can be made by shareholders on Tuesdays or Fridays noon to 9pm; indicate your preference on this form. Winter pick-up (Nov to April) is from Friday noon to Saturday noon.

Satellite groups: If you live a distance away, you may want to consider joining one of our satellite groups. Please call us if you are joining a group for the first time.

If it is within your means, we ask you to consider making a voluntary contribution equalling 3% of your share price. This money will go towards lowering share prices for those unable to pay the full amount. Those with financial hardship may request alternate payment arrangements. Those able to pay in full help us reduce costs.

If you are splitting a Weekly Share, each family or individual must pay the Bi-weekly Share price. If you are splitting a Bi-weekly Share, please provide co-shareholder contact info with this commitment form.

Vacations: We are able to reschedule pick-ups with adequate advance notice.

Share Types and Prices

Full Year Share

Shares begin May 22, 2012 and end May 3, 2013

Each weekly full year share is \$1794 (downpayment of \$598; \$598 due July 1 and Oct. 1). Additional 3% is \$54.

Each bi-weekly full year share is \$933 (downpayment of \$311; \$311 due July 1 and Oct. 1). Additional 3% is \$28.

Half Year Share

Shares begin May 22, 2012 and end Nov. 30, 2012

Each weekly half-year share is \$1239 (downpayment of \$413; \$413 due July 1 and Oct. 1). Additional 3% is \$37.

Each bi-weekly half-year share is \$657 (downpayment of \$219; \$219 due July 1 and Oct. 1). Additional 3% is \$20.

Winter Share Only

Shares begin Dec. 7, 2012 and end May 3, 2013

Bi-weekly winter share is \$406. Additional 3% is \$12.
